Derivation of Section:

This section is former Section 17-13-12, as amended and renumbered by Act 2006- 570, § 80, effective January 1, 2007.

Amendment notes:

**The 2006 amendment**, effective January 1, 2007, in subsection (b) substituted "a county election by the county canvassing board and within 72 hours after certification of the results of a state election by the state canvassing board" for "the election"; in subsection (e) substituted "canvassing board or" for "certifying", and added the second sentence; in subsection (g) deleted the first sentence, and substituted "Costs" for "There being a public interest in fair and accurate elections, costs"; and in subsection (h) substituted "board." for "authority."

Code Commissioner's Notes

In 2006, the Code Commissioner in the second sentence of subsection (h) inserted "voted ballot container" for "box" to reference the apparently intended term.

Former Section 17-16-20 was amended and renumbered as Section 17-6-25 by Act 2006-570, § 29, effective January 1, 2007.

The 1986 amendment designated existing text as subsec. A; and added subsec. B.

The 1987 amendment in subsec. A, inserted "does not exceed fifty votes in the case of a member of the legislature"; and in subsec. B, inserted "elections for" and "or fire district chiefs or secretary-treasurers".

The 1993 amendment, in subsec. B, inserted "precinct committeemen".

The 2003 amendment by Ch. 233, rewrote the section, which had read:

"**A.** when the canvass of returns in a primary or general election shows that the margin between the two candidates receiving the greatest number of votes for a particular office, or between the number of votes cast for and against initiated or referred measures, or proposals to amend the Constitution of Arizona, does not exceed one-tenth of one per cent of the number of votes cast for both such candidates or upon such measures or proposals, or, in any event, does not exceed two hundred votes in the case of an office to be filled by state electors, or an initiated or referred measure or proposal to amend the constitution, does not exceed fifty votes in the case of a member of the legislature or does not exceed ten votes in the case of an office to be filled by the electors of a county or subdivision thereof, a recount of the vote upon such candidates, measures or proposals shall be required.

"**B.** Subsection A does not apply to elections for precinct committeemen, school district governing boards, community college district governing boards, fire district boards or fire district chiefs or secretary-treasurers or boards of other special districts."

The 2004 amendment by Ch. 132 rewrote par. 6 of subsec. A, which had read:

"[**A.**] 6. Ten votes in the case of an office to be filled by the electors of a county or subdivision thereof."

Reviser's Notes:

R.C.1928, § 1271 (Code 1939, § 55-909) is revised to provide in clearer style the procedure for automatic determination by the court of the results of elections for state, county, county subdivision and precinct officers, votes upon initiative and referendum measures, and proposals to amend the constitution, in the instances provided by the above section as originally enacted, and at the same time to preserve the legislative intent in enacting the provision.

Laws 2001, Ch. 317, § 1, eff. June 5, 2001, deleted par. (1)(a), and in par. (1)(b), deleted "If Senate Bill 99-028 is enacted at the first regular session of the sixty-second general assembly and becomes law," preceding "A recount of

any election" and made an attendant capitalization change. Prior to deletion, par. (1)(a) had read:

"If Senate Bill 99-028 is not enacted at the first regular session of the sixty-second general assembly and does not become law, a recount of any election contest shall be held if the difference between the highest number of votes cast in that election contest and the next highest number of votes cast in that election contest is less than or equal to one percent of the highest vote cast in that election contest. A recount shall occur only after the canvass board certifies the original vote count."

Laws 2006, Ch. 86, § 1, in par. (1)(b), inserted "If there is more than one person to be elected in an election contest, a recount shall be held if the difference between the votes cast for the candidate who won the election with the least votes and the candidate who lost the election with the most votes is less than or equal to one-half of one percent of the votes cast for the candidate who won the election with the least votes."

Effect of Amendments

D.C. Law 14-168 rewrote the section which had read:

"(a) If within 7 days after the Board certifies the results of an election, any qualified candidate at such election petitions the Board to have the votes cast at such election recounted in 1 or more voting precincts, the Board shall order such recount. In each such case, the petitioner shall deposit a fee of \$50 for each precinct petitioned to be recounted. If the total cost of the recount is less than the amount so deposited, the difference shall be refunded. If the total cost of the recount is greater than the deposit, the petitioner shall remit payment for such additional costs within 15 days of receipt of notification from the Board that additional costs have been incurred. If the result of the election is changed as a result of the recount, the entire amount deposited by the petitioner shall be refunded. In no case, however, shall the petitioner be required to pay the cost of any recount in any such election if the difference in the number of votes received by the petitioner in connection with any office and the number of votes received by the person certified as having been elected to that office, in the case of an election from a ward, is less than 1 per centum or 50 votes, whichever is less, or in the case of an election at large, is less than 1 per centum or 350 votes, whichever is less."

"(b) Within 7 days after the Board certifies the results of an election, any person who voted in the election may petition the District of Columbia Court of Appeals to review such election. In response to such a petition, the Court may set aside the results so certified and declare the true results of the election, or void the election in whole or in part. To determine the true results of an election the Court may order a recount or take other appropriate action, whether or not a recount has been conducted or requested pursuant to subsection (a) of this section. The Court shall void an election only for fraud, mistake, the making of expenditures by a candidate, or the willful receipt of contributions in violation of the District of Columbia Campaign Finance Reform and Conflict of Interest Act (§ 1-1101.01 et seq.), or other defect, serious enough to vitiate the election as a fair expression of the will of the registered qualified electors voting therein. If the Court voids an election it may order a special election, which shall be conducted in such manner

(comparable to that prescribed for regular elections), and at such time, as the Board shall prescribe. The decision of such Court shall be final and not appealable."

D.C. Law 18-103 rewrote subsec. (a)(1), which had read as follows:

"(a)(1) The Board shall recount the votes cast in one or more voting precincts, if within 7 days after the Board certifies the results of an election for an office, a candidate for that office petitions the Board in writing and specifies the precincts in which the recount shall be conducted. The candidate shall deposit a fee of \$50 for each precinct included in the recount. If the result of the election is changed as a result of the recount, the fee deposited by the petitioner shall be refunded."
